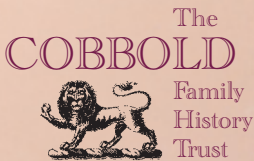

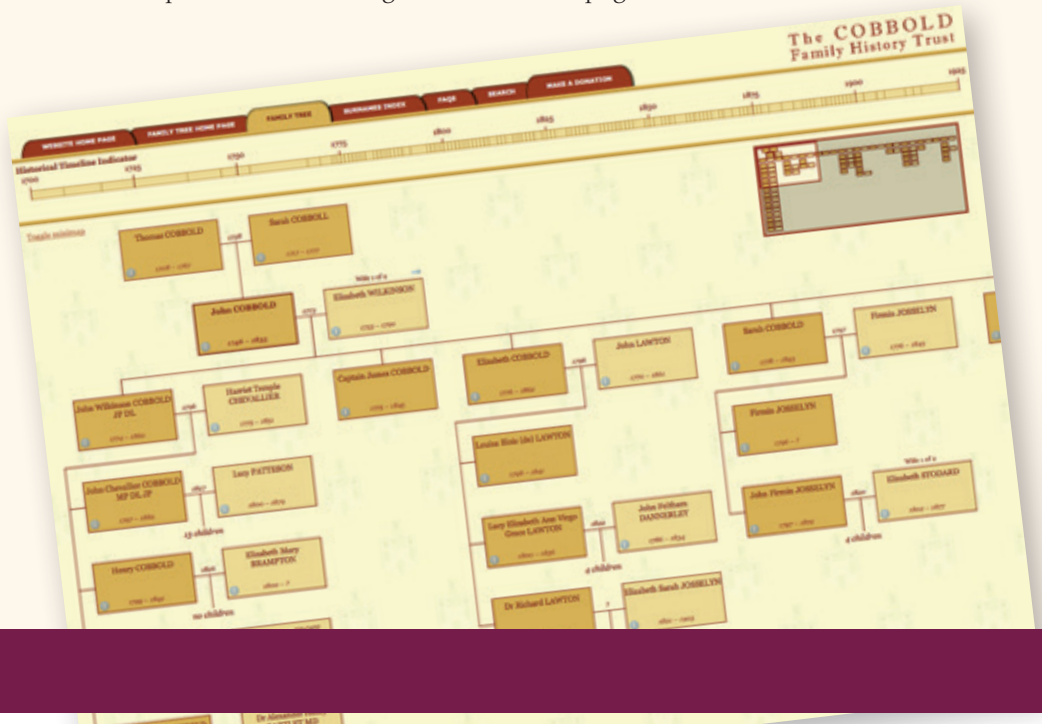
After you have provided for loved ones why not support your family's history?

Registered Charity

As a registered charity all monies left to the Trust are exempt from inheritance tax (IHT). A legacy to the Trust reduces your taxable estate, so more money goes to a cause of your choice and less to the tax man.

Four types of gift

Pecuniary Legacy – a sum of money

Residuary Legacy – a gift of a percentage of your residuary estate

Specific Legacy – any item(s) to be gifted to the Trust for retention or sale

Reversionary Legacy – assets or a sum of money pledged to the Trust but held in trust to be enjoyed by a loved one in their lifetime.

Suggested wording

The following is suggested wording but please check with your solicitor:

'I give The Cobbold Family History Trust, registered charity number 1144757 of 14 Moorfields, Ivybridge, Devon PL21 0XQ hereinafter called CFH Trust, (the sum of £...) or (the residue/...% share of residue of my estate absolutely) or (the.....I own to be retained or sold by the CFH Trust) or (.....* following the death of) and I direct that the proceeds may be used for the general purposes of the CFH Trust and a receipt signed by a person for the time being authorised by the CFH Trust shall be a good and sufficient discharge to my executors.'

**Sum of money, estate or percentage of estate or item.*

The pledge of a legacy is deeply appreciated even before the event and we wish to recognise your generosity in a number of ways.

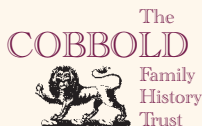
Firstly and importantly we want to write to say thank you, and to listen to any special requests which will be carefully recorded.
